**ARTICLES OF INCORPORATION
OF
Renew Our Faith Corporation**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: **Renew Our Faith Corporation**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
823 Eagle Lane, Apollo Beach, Florida 33572

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: Our organization will be a nonprofit charitable faith based nondenominational organization, raising funds for and providing relief to victims of disasters, those who are in need of emergency funds and those who request financial assistance who cannot get it elsewhere. We specifically will be focused on military, former military, and families of military personell, but will not be restricted to helping those groups.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.



Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
