ARTICLES OF INCORPORATION

In compliance with Chapter 617, F. S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

This corporation was organized exclusively for charitable, scientific and educational purposes, more specifically to focus on organizing and building communities from the grassroots level.

Any such assets not disposed of by the District Court of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
