Article I

The name of the Corporation is: Myra Jenkins Special Childcare Center Inc.

Article III

The purpose of the Corporation is as Follows.

- A. This Corporation is a Not-For-Profit Corporation organized Under Chapter 17, Florida Statues. It is not organized for the private gain of any person. The specific purpose of the Corporation is as follows.

Article IV

Members

The Corporation shall have voting members who shall be elected (and may be removed) by the voting members and who shall have all the rights and privilages of Members of the Corporation.
