Article of Incorporation

Article I

The name of the Corporation is: Myra Jenkins Special Childcare  
Center Inc.

Article III

The purpose of the Corporation is as Follows.

A. This Corporation is a Not-For-Profit Corporation organized Under Chapter 17, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of the Corporation is as follows.

1. To provide special services for children of adolence ages. Services for childcare, daycare preschool and Foster Care.
2. To provide tutoring for Tot's training, special food programs, Headstart and milk programs, as well as potty training and preparation for kindergarten and 1st Grade Entry Student.
3. Specific purpose is to provide special programs for literacy, slow learners and readers, adult daycare services care.
4. To exercise all rights and powers conformed by the laws of the State of Florida upon Non-Profit Corporations.

B. Not withstanding any other provision of the Article, The Purpose for which the Corporation is organized are exclusively religious, charitable, scientific, literacy and educational within the meaning of Section 501 C 3 of the Internal Revenue Code of the 1986 or the corresponding provision of any future U S Revenue Law.


C. Provide however that the Corporation shall not engage in any action which is not permitted to be carried on by non-profit corporation under the Internal Revenue Code and no part of the earnings of the Corporation shall inure to the benefit of or be distributed to it's members, directors, or officers, by the corporation, shall be authorized and empowred to pay reasonable compensation to those people for services rendered and to make payments and distribution in furtherance of it's stated purposes.

Article IV

Members

The Corporation shall have voting members who shall be elected (and may be removed) by the voting members and who shall have all the rights and privileges of Members of the Corporation. The By-Laws may provide for Non-voting members of one or more classes who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the By-Laws, but who shall not have the right to vote. Directors are elected in accordance with By-Laws.

Having been named as Registered Agent and to accept service of process for the above stated Corporation at the place designated in this Certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties and I am familiar with and accept the obligations of my position as Registered Agent.


