ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be:

JUPITER POLICE ASSOCIATION, LOCAL 6008, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The specific purpose(s) for which the corporation is organized is (are):

1. To perpetuate the memory and spirit of Police Sergeants, Police Officers, and Communications Officers who have served before us.
2. To promote economic stability for the membership of this Association by acting as bargaining agent on behalf of Police Sergeants, Police Officers, and Communications Officers of the Jupiter Police Department in matters of policy, salaries, hours of employment, fringe benefits, and all other matters relating to the general good and welfare of the membership.
3. Promote and develop any program or activity for the benefit of members of the Association including pension, hospitalization, insurance, and financing programs.
4. To promote the spirit of cooperation and friendship and a high level of regard dignity and altruism of our calling, among ourselves.
5. To exert a wholesome influence on the citizenry of the Town of Jupiter, and particularly to inculcate respect for law & order.
6. To cooperate with courts and judges thereof, and with branches of our government; national, state, and local.
7. To prevent the inception of subversive groups within our department.
8. To gather, receive, and disseminate such information concerning police service and employment standards as may be helpful to our membership in the pursuit of our calling.
9. To give full cooperation to and arrange unified action with the administrative heads of the department for the betterment of the department.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Nominations of officers scheduled to run for office shall be made either by written notice to the Election Committee at or prior to the nomination meeting in November, or by nomination from the floor at the nomination meeting in November. Nominations will close at the end of the regular November meeting. All persons not present when nominated shall be contacted by the Election Committee within three (3) days after the close of nominations, for confirmation of their candidacy.

Voting shall be conducted by secret ballot among the Association members in good standing. Each member in good standing shall be entitled to one (1) vote. There shall be no proxy and no absentee votes allowed.


