

ARTICLES OF AMENDMENT

to the

Pursuant to, inter alia, the provisions of Florida Statutes § 617.1006, Wuesthoff Assisted Living at IRCC, Inc. adopts, through its sole corporate member, Space Coast Health Foundation, Inc. f/k/a Wuesthoff Health Systems, Inc., the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Wuesthoff Assisted Living at IRCC, Inc. (the "Corporation").

SECOND: The following amendment deletes Article I of the Corporation's Articles of Incorporation in its entirety and inserts the following as a new Article I in the corporation's Articles of Incorporation:

"ARTICLE I - NAME
