This form was recently provided me by our Registered Agent and indicated that it was due by

This form was recently provided me by our Registered Agent and indicated that it was due by September 13 or an additional \$175 reinstatement fee would be required. This took me by surprise since our report was filed on April 25, prior to the required date, and a check for \$61.25 was included at that time.

However, upon discussing this with members of your staff by phone, I was advised that the original filing was incomplete because it did not include an FEI Number. I was also advised that a letter was sent to our Registered Agent advising him of this fact and giving us 30 days to respond. As I explained to your staff, I was unaware of the letter and, and after verifying that our check had been received and deposited on May 15, I continued to periodically check on-line to verify receipt of our report.

However, after checking several times and not finding any record of our report being filed, I called your office. After being advised of the missing FEI number I advised your staff that we had applied for, but had not received the number prior to the original filing. Our FEI number was subsequently received on May 30, 2002.

In order to resolve the issue I was advised to file the additional report with the FEI number included, and include a letter explaining the circumstances as I described them. I was also advised that no additional fee would be required.

The amended 2002 Uniform Business Report is attached. In addition I have included a copy of our check which accompanied the original filing, and a copy of the IRS notice of our FEI number.
