Preface

ARTICLE 3
PURPOSES OF THE CHURCH

The purposes of the Ministerio Pentecostal Pan de Vida, ^{INC.} are to maintain the high standards of Christianity as it is taught in the Bible. These include the commands to :

- 3.1 Proclaim Jesus Christ's divine power in all aspects of life.
- 3.2 Practice all principles of Christian unity that are taught in the Scriptures. This Christian unity is based on the Biblical principle that all Christians are of equal value and worth regardless of race, color, or nationality.
- 3.3 Encourage church members to participate in all projects established for the growth of the Church including:
 - 3.3.1 Spiritual Life - Organization retreats, vigils, fasting, and any other Christian activity that will enhance their spiritual life.
 - 3.3.2 Missionary Tasks - Accomplish the mission that God put in our hands (Matthew 28: 18-20, Mark 16:15-20, Acts 1:8) to go and preach this Gospel to every nation.
 - 3.3.3 Educational Aspect - To enhance Sunday School teaching and to establish a Bible Study Institute to prepare those who have a ministry call from God.

 - 3.3.5 Political Aspect - To separate the Church from the State and all secular orientation.

ARTICLE 4

STATEMENT OF FAITH

As a Christian Church committed to the advancement of the Gospel of Jesus Christ in all of its affairs, the attached Statement of Faith is hereby adopted to direct the activities and purposes of the Church. Each Board member, officer and employee must annually subscribe to this Statement of Faith as a prerequisite to serving in their Church capacity.

4.1 Trinity

We believe in one God all mighty creator of heaven and earth. Our God is one, but represent as the Father, the Son and the Holy Spirit; and these three are one.

4.2 Jesus Christ

We believe in Jesus Christ, the second person of the Trinity, who is one with the Father, who was born of the Virgin Mary, who is fully God and fully man, who is the true God and eternal life (1 John 5:20). We believe He died for our sins, and was raised from the dead and is seated at the right hand of the Father in heaven interceding for us.

We believed in the Holy Spirit, the third person of the Trinity, who is always present in the Church of God. It is the Holy Spirit of God that Jesus promised to those who believe in Him that they will received power when the Holy Spirit is come upon them (Acts 1:8).

4.4 Holy Scriptures

We believe all that is said in the sixty six books of the Bible because these books are inspired by the Holy Spirit not by man (2 Peter 1:20-21).

4.5 Original Sin

We believe that sin started with Adam when he disobeyed God by eating the fruit from the tree of knowledge. Since then men has been separated from God until coming to Christ and personally accepting Him as Savior.

4.6 The Propitiation

We believe that man's soul can only be save by accepting Christ as his own Savior since He was delivered for our offenses and was raised again for our justification (Romans 5:1)

4.7 Free Will

We believe mankind is created in God's image and given a free will to choose good or bad. Since the moment Adam sinned, man has been in sin unless coming to Jesus Christ for forgiveness. As it says in Romans 5:18, "therefore as by the offense of one (Adam) judgment came upon all men to condemnation; even so by righteousness of one (Jesus Christ) the free gift came upon all men unto justification of life."

4.8 Repentance

We believe that there is true repentance when a person comes to Christ and confesses his sins to Him. This person immediately is forgiven and becomes born again in the Spirit and as a Christian is guided by the Holy Spirit . The Holy Spirit is always present to help each believer to live a Christian live and always have a testimony that glorifies God as a follower of Jesus Christ.

4.9 Justification, Regeneration, and Adoption

We believe that those who accept Jesus Christ as their Savior are justified to the Father by faith in Jesus Christ. Their sins are totally forgiven from the moment they accept Christ as their Lord and their Savior.

4.10 Sanctification

We believe that Christians, although in the world, must live a life devoted to God and not of the world (Romans 12:1, 2; 1 Thes. 5:23; Heb. 13:12). Also, the Bible teaches that we live a holy life to see the Lord. It is by the Holy Spirit that we can accomplish this, and follow the commandment of "Be ye holy; for I am Holy" (1 Peter 1:16). The believer is sanctified by recognizing Jesus Christ as Savior and always yielding to the guidance of the Holy Spirit.

4.11 Promise of Eternal Life

We believe that at the coming of Jesus Christ, those who sleep in Jesus will be raised from the dead and those who are alive and remain shall be caught up together with them in the clouds to meet the Lord in the air and so shall they ever be with the Lord. As Christians, we believe that we will live eternally with Christ after the rapture of the Church. (1 Thess. 4:14-17)

4.12 The Church Ordinances

4.12.1 Baptism With Water

All Christians should be baptized with water in the name of the Father, the Son, and the Holy Spirit. This meant to symbolize dying with Christ and at the same time being raised with Him forever (Matthew 28:19; Mark 16:16; Acts 10:47-48; Romans 6:4).

4.12.2 The Lord's Supper

The Lord's Supper consists of bread and wine. These represent the divine nature of the Lord Jesus Christ. By eating the bread and drinking the cup of wine we proclaim His coming (1 Cor. 11:26). All who partake in the Lord's Supper must first be baptized with water and reconciled to God in Christ.

4.13 Divine Healing

We believe what the Bible says about the power that was given to the Church to lay hands on the sick, and they shall recover by the faith in the Lord (Isaiah 53:4-5; Mark 16:18; James 5:14-16).

4.14 The Church

We believe the Church is the body of Christ. God sent his Son to save those who were lost, and made of them the body of Christ on earth.

The Ministerio Pentecostal Pan de Vida as part of the Church of God is to:

- 4.14.1 Be a place where Christian believers can congregate to worship God.
- 4.14.2 Be an organization of God here on earth whose main purpose is to spread the Gospel of Jesus Christ to this lost world.
- 4.14.3 Be a place where believers congregate and become the body of Christ here on earth.
- 4.14.4 Teach and prepare evangelist who are filled with the Holy Spirit.
- 4.14.5 Aid the members of the congregation in discovering and growing in their special relationship with God and teaching them to always be victorious in their spiritual lives.
- 4.14.6 Teach the congregation to about the gifts and fruits of the Holy Spirit and the various ministries where God may be calling them to serve.

4.15 The Church Tithe

We believe God commands believers to tithe for the growth of the ministry to cover the Church's expenditures (Genesis 10:28-28; Malachi 3:10; Matthew 23:23; and 2 Corinthians 9:6-9).

4.16 Marriage

We believe that marriage is a commitment instituted by God and that all married people should always remain together. Based on the Scriptures there is only one reason why a married couple may get a divorce and that is if one of them has committed adultery (Matthew 5:31-32; 19:3-9).

4.17 Governance

We believe that the local Church is God's ordained organizational instrument of the age and that the local Church is to be governed by its Elders. We also believe that God calls some to serve and minister to the local Church as Deacons who are accountable to the Church Elders.

4.18 Government

We believe that God has permitted the existence of governmental institutions. Therefore, we teach the congregation to respect these institutions.

ARTICLE 5

MEMBERS

Membership in the Church shall be determined by the Bylaws. Each regular attendee and member of the Church should be up to date with his or her financial responsibilities to the Church and, as a son of God, is accountable to the Elders for the maintenance of a personal testimony that glorifies God.

ARTICLE 6

GOVERNANCE

The Church shall be governed by the decisions of a Board of Elders, the parameters of which shall be set forth in the Bylaws. The Church shall also have Trustees, Deacons, and officers as provided for in the Bylaws. These individuals shall be organized as a Legislative Committee, an Executive Committee, a Ministerial Committee, and a Management team as provided for in the Bylaws.

ARTICLE 7

TAX-EXEMPT PROVISIONS

7.1 Tax Exempt Purposes

Ministerio Pentecostal Pan de Vida as a church^{INC.} shall be organized and operated so as to be eligible for and maintain federal tax exempt status pursuant to the mandatory exception provisions of Section 508 (c) (1) of the Internal Revenue Code of 1986 or the corresponding section of any future federal tax code (hereinafter "the Code"). The Church is organized exclusively for, and its property is irrevocably dedicated to charitable, educational and religious purposes, and no part of the net earnings of the Church shall inure to the benefit of or be distributable to its Trustees, Elders, Deacons, or Pastors or other private persons, except that the Church shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its proposes as set forth in these Articles. Notwithstanding anything contained herein, no loan shall be made by the Church to any of its Trustees, Elders, Deacons or officers. No part of the net earning of the Church shall be inure to the benefit of any private shareholder or individual. No substantial part of the activities of the Church shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Church shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf

of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Church shall not carry on any activity not permitted to be carried on: (1) by a Church exempt from federal income tax under Section 501 (c) (3) of the Code; or (2) by a Church, contributions to which are deductible under Section 170 of the Code.

7.2 Dissolution or Liquidation

In the event of dissolution or final liquidation of the Church, none of the property of the Church nor any proceeds thereof shall be distributed to, or divided among, any of the Elders, or officers of the Church, or inure to the benefit of any individual. After all liabilities and obligations of the Church have been paid, satisfied, and discharged, or adequate provisions made therefore, all remaining property and assets of the Church shall be distributed to one or more organizations designated: (1) pursuant to a plan of distribution adopted as provided for under the law of the State of Florida; or (2) if there be no appropriate plan of distribution, as a court may direct (pursuant to the laws of the State of Florida) provided that such property shall be distributed only to organizations which shall comply with all of the following conditions:

7.2.1 Such organization shall be organized and operated exclusively for religious purposes consistent with the Statement of Faith of the Church.

7.2.2 Transfers of property to such organization shall, to the extent permitted under statutes of the United States, be exempt from federal gift, succession, inheritance, estate, or death taxes (by whatever name called).

7.2.3 Such organization shall be exempt from federal income taxes by reason of Section 501 (c) (3) of the Code.

7.2.4 Contributions to such organization shall be deductible by reason of Section 170 of the Code.

ARTICLE 8

AMENDMENTS

These Articles of Incorporation of the Church can be amended only by the vote of at least 75% of the elected Elders and Members at meetings called for such purpose when a quorum is present and at least seven days notice has been given of the purpose of the meeting and the content of the proposed amendment.

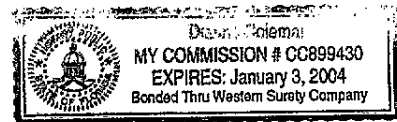
