ARTICLES OF INCORPORATION OF B & B Family Evangelistic Outreach Ministries, Inc. a Not-For-Profit Corporation

The undersigned Incorporator by these Articles associates herself/himself for the purpose of forming a corporation under the Florida Not-For-Profit Corporation Act, hereby adopts the following Articles of Incorporation.

Article I. Name

Article V. Manner of Election

The Board of Directors shall be comprised of ordained and licensed ministry whenever possible, or others meeting the scriptural requirements of an Elder (Titus 1:5-9, 1 Timothy 3:1-7), known as the Board of Elders.

The Officers of the Corporation shall be elected by the Board of Elders. There shall be a Chairman on the Board, a President, Vice President, Secretary and Treasurer and such other officers as the Board of Elders may appoint. One person may hold two or more offices. The office of President shall also be the Chairman of the Board of Elders.

Article VI Bylaws

The power to adopt, alter, amend or repeal the Bylaws shall be vested in the Board of Directors.

Article VII Amendments

This corporation reserves the right to amend or repeal any provisions contained within these Articles of Incorporation, or any amendment thereto, through its Board of Directors. which action shall require a seventy-five percent (75%) vote of the Board of Directors.
