The undersigned incorporators by these articles associate themselves for the purpose of forming a corporation not for profit under the laws of the State of Florida, and adopt The following articles of incorporation.

ARTICLE I: NAME AND PURPOSE

The name of this corporation is **CITIZEN'S MIAMI ASSOCIATION, INC.** For convenience, the corporation shall be referred to in this Instrument as the "association," these articles of incorporation as the "articles," and The bylaws of the association as the "bylaws." Purposes of the Association.

The objects of the Citizen's Miami Association in Miami FL shall be:

1. Fight against crime, corruption, terrorism and racial profile.

ARTICLE II. ORGANIZATION


