The undersigned, acting as incorporators of a Corporation pursuant to Chapter 610 Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE 1

The name of the corporation shall be FAITH WORSHIP TEMPLE, INC. The initial principal address of the corporation is:

ARTICLE VII

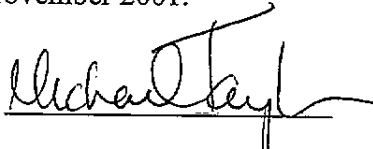
