To Whom It May Concern:

I have been notified that my non-profit Corporation, Willie B. Ellis Foundation, Inc., has been in dissolution or revocation, since May 2003. The problem is that my mailing address is the Willie B. Ellis Police Substation, 1220 Avenue "D", Fort Pierce, FL 34950. I am an employee of the City of Fort Pierce as was my father, Willie B. Ellis, who was killed in the line of duty July, 17, 1966.

I created the foundation in honor of my father and I still have not worked as diligently as I should in order to make the corporation a success as far as giving scholarships to deserving students. I have never collected any monies for funds for the corporation, so therefore I never applied for an EIN number from the IRS. However, as your co-worker, Katrina, explained that the EIN verifies that we are a not-for-profit corporation.

The reason I did not respond in the thirty-day grace period is because the mail goes directly to the Police Substation and I was terminated last May and the mail was still forwarded to my desk in City Hall. After five months of hearings before the Civil Service Board, I was granted reinstatement October 22, 2003. After going through all the mail that accumulated for five months during my absence, I discovered the Willie B. Ellis Foundation was in a state of dissolution or revocation and then called your office. Katrina informed me that my \$61.50 check for yearly update was being held until I provided an EIN number. Now I have the EIN #75-3133821 from the IRS. The contact

number is 1-800829-1040, I spoke with Mary and her ID number is: 28-12014. I received the EIN number Friday, 10/24/03, Mary said the official papers will be received within ten days.

Please waive my reinstatement fee and grant my corporation restoration. Thank you for your prompt consideration to this matter.
