ARTICLES OF INCORPORATION OF



EVERS ACRES HOMEOWNERS' ASSOCIATION, INC. a Florida Not for Profit Corporation

The undersigned persons, acting as incorporators of a corporation not for profit under the Florida Note For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is EVERS ACRES HOMEOWNERS' ASSOCIATION, INC.

ARTICLE II

Duration

The corporation shall have perpetual duration.

ARTICLE III

Purpose

The corporation is a not for profit corporation. The purpose for which the corporation is organized is to provide for the use, control, maintenance, improvement, and repair of the common property areas, including private streets and any required storm water retention or drainage ponds or improvements, of that certain unplatted subdivision known as Evers Acres which is located in Escambia County, Florida. Further, this purpose is to comport and comply with the requirements of Florida Statutes, Chapter 720, Homeowners' Associations, as may be amended from time to time and as may apply to said corporation and the

property owners comprising the membership of the association.

ARTICLE IV

Membership

The corporation is organized upon a non-stock basis. The corporation shall have a membership distinct from the Board of Directors, although members of the corporation may serve on the Board of Directors. The membership shall consist of those owners of record of real property encompassed in Evers Acres, an unplatted subdivision in Escambia County, Florida. The authorized number and qualifications of the members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability for dues and assessments and the method of collection thereof, shall be as regulated in the Bylaws of the corporation and consistent with Florida Statutes, Chapter 720, Homeowners' Association, as may be amended from time to time.

ARTICLE V

Association Property/Lien Rights

All private streets and drainage improvements of Evers Acres, an unplatted subdivision in Escambia County, Florida, shall be owned by this Association, and all record title landowners of said unplatted subdivision shall be members of the Association. As allowed by law, the Association shall have the right of lien foreclosure against a member's property for non-payment of property assessment which has been properly assessed by the Association's Board of Directors when such assessments are for drainage and/or road maintenance.

ARTICLE VI

Principal Office, Registered Office, and Registered Agent

The street address of the principal office and the initial registered office of

the corporation is 5429 Highway 29 North, Molino, Florida 32577. The name of its initial registered agent at such address is Bobby D. Evers, Sr.

ARTICLE VII

Board of Directors

The powers of this corporation shall be exercised, its property controlled, and its affairs conducted by a Board of Directors. The number of directors of the corporation shall be not less than three (3); provided, however, that such number may be changed by a bylaw duly adopted pursuant to the bylaws of this corporation and consistent with Florida law.

Directors elected at the first annual meeting, and at all times thereafter, shall serve for a term of three (3) years until the annual meeting of members following the election of directors and until the qualification of the successors in office. Annual meetings shall be held during regular business hours, unless otherwise duly noticed, on the first Monday in March of each year at the principal office of the corporation, or at such other place or places as the Board of Directors may designate from time to time by resolution.

Any action required or permitted to be taken by the Board of Directors under any provision of law may be taken without a meeting if all the members of the Board shall individually or collectively consent in writing to such action. Such written consent or consents shall be filed with the minutes of the proceedings of the Board, and any such action by written consent shall have the same force and effect as if taken by unanimous vote of the directors. Any certificate or other document filed under any provision of law that relates to action so taken shall state that the action was taken by unanimous written consent of the Board of Directors without a meeting and that the Articles of Incorporation and Bylaws of this corporation authorize the directors to so act.

Such a statement shall be prima facie evidence of such authority.


