ARTICLES OF INCORPORATION

SEA WINDS OF AMELIA HOMEOWNER'S ASSOCIATION, INC. A nonprofit corporation

I, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree as follows:

ARTICLE L

The name of the corporation shall be: SEA WINDS OF AMELIA HOMEOWNER'S ASSOCIATION, INC., a nonprofit corporation..

ARTICLE II.

The address of the principal office of SEA WINDS OF AMELIA HOMEOWNER'S ASSOCIATION, INC., a nonprofit corporation., shall be 144 LONGPOINT DRIVE, FERNANDINA BEACH, FLORIDA 32034, and the mailing address of said corporation shall be 144 LONGPOINT DRIVE, FERNANDINA BEACH, FLORIDA 32034. The association may have such other offices as may from time to time be designated by its members or as may be established by resolution of the Board of Directors.

ARTICLE III.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to act as homeowners association for the benefit of the property owners of the Sea Winds, a subdivision in Nassau County, Florida. The Association shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River

Water Management District permit requirements and applicable District rules, and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water or stormwater management system.

ARTICLE IV.

The manner in which the directors are to be elected or appointed is as stated in the bylaws.

ARTICLE V.

The name and address of the incorporator of these Articles is:

ARTICLE VI.

Existence of the Association shall commence with the filing of these Article s of Incorporation with the Secretary of State, Tallahassee, Florida. The Association shall exist in perpetuity.

ARTICLE VII.

In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved by the St. Johns River Water Management District prior to such termination, dissolution or liquidation.

ARTICLE VIII.

The street address of the corporation's initial registered office and the name of its initial registered agent at that address is:

ARTICLE IX.

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of its Board of Directors, subject to any limitation set forth in these Articles of Incorporation. This corporation shall have one (1) Director, initially.

ARTICLE X.

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
