ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Religious ministry to children of the streets, prisoners, drug addicts, shanty town persons and anyone whom society would deem to be of little or no value in Latin American. Our aim is to help alleviate the social and spiritual deprivation of the poorest of poor people, especially the children, by linking God's mercy with human need.

Notwithstanding any other provision of these articles, the purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (C) (3) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.


ARTICLE VIII DISSOLUTION
