The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I NAME**

The name of the corporation shall be: **Clermont Community Church Inc.**

**ARTICLE II PRINCIPAL OFFICE**

**ARTICLE III PURPOSES**

The specific purpose for which the corporation is organized is: The corporation is being formed to meet the legal requirements of a church seeking Non-profit status.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


