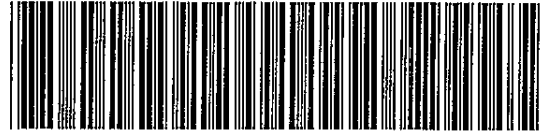

5. Provide the members with advance training and equip in Biblical and doctrinal studies, ministry and leadership skills so they may be prepared to do the "work of the ministry".

Worldwide Church of Bethel, Inc. is a religious institution with the purpose of presenting God in such a manner as it may readily understood, and will bring Christians into a vital and effective relationship with our Lord Jesus Christ. The members will then prove to be channels for further spreading of the Word and strengthening of the testimony of Bible-believing Churches.

This corporation is organized exclusively for educational and religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations.
