Article III, Purpose(s); The specific purpose(s) for which this corporation is organized (are):

The purpose(s) for which *New Beginning Fellowship Church, Inc.* is organized are exclusively religious, scientific, literary, and educational within the meaning of Section 501©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any provision of these articles, this organization shall not carry on any activities not permitted to be carried on by any organization exempt from federal income tax under Section 501©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

This corporation shall also establish ministries wherever deemed necessary for the purpose of; training and ordaining men and women to ministries; teaching and preaching Scriptural and Biblical doctrine; food pantries to assist the needy; soup kitchens to feed the poor and homeless; and other ministries.

Articles IV, Manner of Election of Directors; The manner in which Directors are elected shall be as follow:

Article V, Limitations of Corporate Power;

The corporate powers of this corporation are as provided in Section 617.0302m, Florida Statutes, unless limited, are as follows:
