

- ONE: The name and address of this principal corporation is **Miami Palmetto High School West Perrine Class Of 1970 Inc.**, 19640 SW 127 Court, Miami Florida 33177- 4810. The corporation is organized pursuant to the Florida Nonprofit Corporation Code.
- TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Child Care, Job Training, Job Placement, Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, Elderly Care and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual. It shall have no stock.
- FOUR: The address of the Registered office is 19640 SW 127 Court, **Miami, Florida 33177- 4810**. The REGISTERED AGENT at the office shall be:

- FIVE:
- (a) This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
 - (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a corporation contributions of which are deductible under Section 170 (c)(2) of the Internal Revenue Code.
