ARTICLES OF INCORPORATION

OF

ST. AUGUSTINE BIBLE INSTITUTE & COLLEGE, INC.

The undersigned, for the purpose of forming a corporation pursuant to the Florida Not-for-Profit Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE I

CORPORATE NAME

The name of the Corporation is ST. AUGUSTINE BIBLE INSTITUTE & COLLEGE, INC.

ARTICLE II

TERM OF EXISTENCE

Existence of the Corporation shall be perpetual. Corporate existence shall commence upon the filing of these Articles of Incorporation.

ARTICLE III

NATURE OF BUSINESS

The purposes for which the Corporation is initially organized are the transaction of any and all business and activities which a not-for-profit Corporation may conduct in accordance with the laws of the State of Florida and for all matters related to the mutual benefit to the provision of courses of religious study.

ARTICLE IV

PRINCIPAL PLACE OF BUSINESS AND REGISTERED AGENT

The street address and mailing address of the initial principal office of the Corporation shall be 132 Oviedo Street, St. Augustine, Florida 32084, and the name and address of the initial registered

agent for the Corporation are Ronald W. Brown, 66 Cuna Street, Suite A, St. Augustine, Florida 32084.

ARTICLE V

BOARD OF DIRECTORS

The initial Board of Directors shall consist of four (4) members, but such number may be increased or decreased as provided in the By-Laws of the Corporation, provided that the number of Directors shall not be fewer than three (3). 
ARTICLE VII

AMENDMENTS






