The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be: Friends Reaching Friends, Inc., A Non-Profit Corporation.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be 2801 North University Drive, Pembroke Pines, Florida 33024.

ARTICLE III. PURPOSE

The specific purpose for which the corporation is organized is: Friends in South Florida Reach Out to our Friends who live in the USA or in Foreign Countries for the purpose of ministering to their spiritual, education, emotional, environmental (including buildings & dwellings), and recreational needs.
