Recently I was engaged to be the Certified Public Accountant for Grant Court Villas Homeowners Association, Inc. In finding the 2002 Uniform Business Report was not filed I am taking immediate action. On April 15, 2002, a Meeting of the Board of Directors met and the directors resigned naming 3 (three) new directors. Unbeknownst to Mr. Kunz the Annual Report was not filed for that year. We are submitting the enclosed Annual Report Filing Form along with a check in the amount of \$61.25. It is at this time that we ask that you please consider abatement of the \$175.00 fee to reinstate "GRANT COURT VILLAS HOMEOWNERS ASSOCIATION, INC." as a current and active corporation with the State of Florida.

The enclosed documentation will confirm the election of the new officers. As indicated above the officers were not familiar with Annual Report filing requirements. This is a one time event.


We respectfully request that you accept the enclosed application and fee at this time to reinstate the corporation.
