Articles Of Incorporation

In Compliance With Chapter 617, F.A., (Not for Profit)

Article 1: Name

The name of the Organization will be EuroTrash, Inc.

Article 2: Principle Place of Business & Mailing Address

The address of the EuroTrash, Inc. will be 201 West Laurel Street #512, Tampa, FL 33602.

Article 3: Purpose

The EuroTrash, Inc. is organized exclusively for charitable purposes, more specifically to end discrimination and bias based on sexual orientation and gender identity through educational programs, cultural awareness and community development. To this end, The EuroTrash, Inc., shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c) of the Internal Revenue code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to an organization that qualifies as exempt under Section 501 (c) of the Internal Revenue code of 1986, as now enacted or hereafter amended.

Article 4: Election of Directors

For the initial (11) months of operation, Directors of the organization shall be the founders of the EuroTrash, Inc. or persons appointed by the founders based on certain skills and areas of expertise required to develop The EuroTrash, Inc. charitable pursuits. Commencing in January¹ of 2002, the Directors will be elected annually for a year term by a majority vote at the Annual Meeting to be conducted every December.
