**ARTICLE I - CORPORATE NAME AND PRINCIPAL ADDRESS**

The name of this corporation is Youth Sports Foundation, Inc. and the principal address of the corporation is 1519 NE Capital Circle #21, Tallahassee, Florida 32308.

**ARTICLE II - TERM OF EXISTENCE**

This corporation shall have perpetual existence.

**ARTICLE III - PURPOSES FOR WHICH THE CORPORATION IS ORGANIZED**

The purposes for which this corporation is formed is to operate exclusively for the advancement of education, relief to underprivileged or at risk children, combating juvenile delinquency other charitable purposes as set forth in Section 501 (c)(3) of the Internal Revenue Code of 1986. The corporation shall have all powers as provided in Section 617.0302, Florida Statutes (2000) and as subsequently amended unless otherwise prohibited in these Articles of Incorporation or Bylaws.

**ARTICLE IV - PROHIBITED TRANSACTIONS**

This corporation shall not:

- A. Engage in any activities prohibited by Section 617.0835, Florida Statutes;
- B. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

#### **ARTICLE V - REGISTERED AGENT AND REGISTERED OFFICE**

The street address of the registered office of the corporation is 502 East Park Avenue, Tallahassee, Florida 32301. The name of the registered agent at such address is Richard W. Moore.

#### **ARTICLE VI - DIRECTORS**

Highest-ranking instructor in the corporation shall select the directors for Youth Sports Foundation, Inc. The highest-ranking instructor must be one of the directors and shall be designated as the chairman of the board of directors. The initial directors for Youth Sports Foundations, Inc. are:

#### **ARTICLE VII - MANAGEMENT OF CORPORATE AFFAIRS**

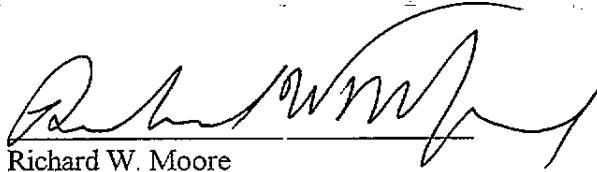
