Articles of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE 1 NAME

The name of this corporation shall be: Church of Internal Light, Inc.

ARTICLE 2 PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 30510 Reed Rd. Dade City, FL 33523.

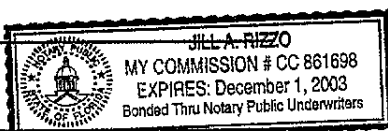
