**ARTICLE I NAME**

The name of the corporation shall be **COLLIER RESIDENTS ADVOCATE SAFE HIGHWAYS, INC.**

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is to protect the residents of Collier County living in the vicinity of and using Collier Boulevard and roads that intersect it from the impacts of development which exceed the ability of Collier Boulevard to function safely and at an acceptable level of service, and to ensure that all such developments are consistent with the Collier County Growth Management Plan.

**MANNER OF ELECTION**

The directors shall be elected by a majority vote of the existing directors of the corporation at any regular or special meeting called for that purpose with the number of directors not to exceed fifteen. The term of office of each director shall be one year from the date of his election as a director, regardless of whether he is filling the unexpired term of a former director, unless the corporation's bylaws otherwise provide. The term of office of the corporation's initial directors shall be one year from the date of the corporation's organization, subject to reelection as herein provided.

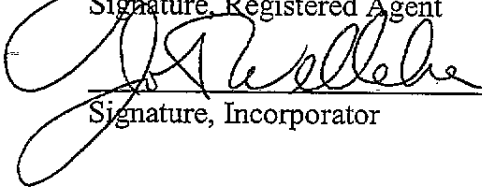
