The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: Northwest 19th Street Social Club, Inc..

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III - EFFECTIVE START December 14th, 2001

The effective start December 14th, 2001 of the corporation shall be January 1st, 2002

ARTICLE III - PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

Charitable works, financial responsibility for the community, sponsorship of sporting and church events, promoting community harmony.

The property of this corporation is irrevocably dedicated to the charitable purpose and no part of the net income or assets of this organization shall ever insure to the benefit of any private person. Upon dissolution of the organization, assets shall be distributed for one or more exempt purpose within the meaning of section 501 (c) (3) of the Internal Revenue Code or corresponding section fo any future federal code, or shall be distributed to the Federal, State or local government for public purposes.

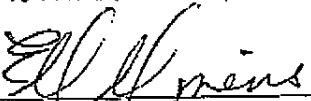

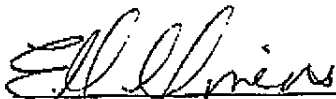
