## ARTICLES ON INCORPORATION for

CHRISTIAN DELIVERANCE OUTREACH MINISTRY, INC.

#### AMENDMENT to ARTICLE III PURPOSE(S)

- Christian Deliverance Outreach Min., Inc. is organized exclusively for charitable, religious, educational, and section 501 © (3), including, for such purposes, the making of distributions to Christian Deliverance Outreach Min., Inc. that qualify as exempt organizations under section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 2. No part of the net earnings of Christian Deliverance Outreach Min., Inc. shall inure to the benefits, or be distributable to its members, trustees, officers, or other private persons, except that Christian Deliverance Outreach Min., Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and Christian Deliverance Outreach Min., Inc. shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, Christian Deliverance Outreach Min., Inc. shall not carry on any other activities not permitted to carried on
  - (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or
  - (b) by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 3. Upon the dissolution of the Christian Deliverance Outreach Min., Inc., assets shall be distributed for one or more exempt purpose within the meaning of section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court Common Pleas of the county in which the principal office of Christian Deliverance Outreach Min., Inc. is then located, exclusively for such purposes or to Christian Deliverance Outreach Min., Inc., as said Court shall determine, which are organized and operated exclusively for such purposes.
