

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby present these Articles for the formation of a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is: CROSSROAD BAPTIST CHURCH OF PUTNAM COUNTY, INC., A NON-PROFIT CORPORATION.

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in every phase and aspect of any lawful business for which corporations may be incorporated under the Florida Not-for-Profit Corporation Act.

To do all and everything necessary and proper for the accomplishment of any of the purposes of the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendments thereof, and either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes and objects of this corporation.

The foregoing enumeration of objects and purposes shall not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.

ARTICLE III

This corporation is organized as a church exclusively for charitable, religious, and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law), including, but

not limited to, for such purposes as the establishing and maintaining of religious worship, the building, maintaining and operating of churches, parsonages, schools, chapels, radio stations, rescue missions, print shops, day-care centers, camps, nursing homes, and cemeteries and other ministries that the Church may be led of God to establish.

ARTICLE IV

This corporation is to exist perpetually.

ARTICLE V

The initial post office of this corporation in the State of Florida is P. O. Box 706, 111 River Road, Satsuma, Florida 32189. The Board of Directors may from time to time move the principal office to any other address in Florida. The name of the initial registered agent is Homer Stallings whose address is 111 River Road, Satsuma, Florida 32189.

ARTICLE VII

This corporation shall have four directors, initially. The number of directors may be increased or diminished from time to time by By-Laws adopted by the members. The method of election of directors is as stated in the church by-laws.

ARTICLE IX


The corporation shall indemnify any and all persons who may serve or who have served at any time as directors or officers, or who at the request of the Board of Directors of the corporation may serve or at any time have served as directors or officers of another corporation in which the corporation at such time owned or may own shares of stock or of which it was or may be a creditor, and their respective heirs, administrators, successors and assigns against any and all expenses, including amounts paid upon judgment, counsel fees, and amount paid in settlement (before or after suit is commenced), actually and necessarily incurred by such persons in connection with the defense or settlement of any claim, action, suit or proceeding in which they, or any of them, are made parties, or a party, or which may be asserted against them, or any of them, by reason of being or having been directors or officers, or a director or officer, of the corporation, or of such other corporation, except in relation to matters as to which any such director or officer, or former director or officer, or person shall be adjudged in any action, suit or proceeding to be liable for his own negligence or misconduct in the performance of his duty. Such indemnification shall be in addition to any other rights to which those indemnified may be entitled under any law, by-law agreement, vote of members or otherwise.

ARTICLE X

These Articles of Incorporation may be amended in the manner provided by law.

All rights of members are subject to this reservation.


