ARTICLES OF INCORPORATION OF STABLE MINISTRIES, INC.

ARTICLE ONE

THE NAME OF THIS CORPORATION SHALL BE: STABLE MINISTRIES, INC.

ARTICLE TWO

THIS CORPORATION IS TO HAVE PERPETUAL EXISTENCE. ITS PRINCIPAL PLACE OF BUSINESS IS SUITE 500, HQ ORLANDO, SW, 7380 SAND LAKE ROAD, ORLANDO, FLORIDA, AND ITS MAILING ADDRESS IS POST OFFICE BOX 2375, GOLDENROD, FLORIDA 32733-2375.

ARTICLE THREE

THE GENERAL PURPOSE OF THIS CORPORATION IS TO CONDUCT ANY LAWFUL BUSINESS WHICH CORPORATIONS NOT FOR PROFIT MAY TRANSACT UNDER THE LAWS OF THE STATE OF FLORIDA. IN ADDITION THERETO, THE PURPOSE IS TO EQUIP LOCAL CHURCHES IN RURAL AMERICA TO OPEN AND OPERATE ACTIVITY CENTERS FOR YOUTH, WHERE RELATIONSHIPS CAN BE DEVELOPED THAT WILL HELP AREA YOUTH ESTABLISH AND GROW IN THEIR FAITH IN JESUS CHRIST, AS THEY LEARN TO APPLY THE SCRIPTURES OF THE OLD AND NEW TESTAMENTS AS THEIR SUFFICIENT GUIDE IN MAKING ALL OF LIFE'S DECISIONS AND WITH THE GOAL OF WORKING WITH CHURCHES IN PROVIDING MINISTRY OPPORTUNITIES FOR AND BY THE YOUTH.

ARTICLE FOUR

THE BOARD OF DIRECTORS WILL CONSIST OF A MINIMUM OF THREE MEMBERS TO A MAXIMUM OF EIGHT MEMBERS. THE NUMBER OF DIRECTORS MAY BE CHANGED BY THE BY-LAWS OF THE CORPORATION BUT SHALL BE NO LESS THAN THREE.

THE ORIGINAL DIRECTORS SHALL BE APPOINTED BY THE INCORPORATOR AND ARE LISTED BELOW. VACANCIES ON THE BOARD OF DIRECTORS SHALL BE FILLED BY A MAJORITY VOTE OF THE REMAINING

MEMBERS OF THE BOARD TO FULFILL THE REMAINING TERM OF THE VACANCY.

AT THE ANNUAL MEETING, THE BOARD OF DIRECTORS WILL NOMINATE A SLATE OF CANDIDATES TO FILL ANY VACANCIES TO THE MEMBERS OF THE BOARD WHO WILL THEN ELECT THOSE WHO WILL SERVE. CANDIDATES MUST RECEIVE A MAJORITY VOTE OF THE MEMBER OF THE BOARD IN ATTENDANCE AT THE ANNUAL MEETING IN ORDER TO SERVE.

ANY DIRECTOR MAY BE REMOVED BY A MAJORITY VOTE OF THE BOARD OF DIRECTORS.

DIRECTORS WILL SERVE FOR A PERIOD OF THREE YEARS OR UNTIL THEY RESIGN OR ARE REMOVED FROM OFFICE.

THE DAY-TO-DAY BUSINESS OF THE CORPORATION WILL BE RUN BY A PRESIDENT, SECRETARY AND TREASURER. THESE OFFICERS WILL SERVE UNTIL REPLACED BY A MAJORITY VOTE OF THE BOARD OF DIRECTORS. THE ORIGINAL OFFICERS ARE APPOINTED BY THE INCORPORATOR AND DESIGNATED BELOW.
