ARTICLES OF INCORPORATION

OF

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of this corporation is:

REHAVAM ZE'EV SYNAGOGUE, INC.

The principal place of business of this corporation shall be 17435 N.E. 7th Avenue, North Miami Beach, Florida 33162, and the mailing address shall be the same.

ARTICLE II

Said corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future

Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

ARTICLE III

The membership of this corporation shall constitute all persons hereinafter named as officers and directors and such other persons hereinafter named as officers and directors and such other persons as from time to time may become members.

ARTICLE IV

The Board of Directors shall be elected and hold office in accordance with the Bylaws.




ARTICLE VII
