

- ONE:** The name and address of this principal corporation is Perfecting Ministries, Inc. 17 Juniper Pass Trail Ocala , FL 34480. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.
- TWO:** This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. 
