ARTICLES OF INCORPORATION

ARTICLE I

Name

The name of this corporation shall be: HOPE CENTER INTERNATIONAL MINISTRIES, INC.

ARTICLE II

Principal office

The principal office of the corporation shall be located at 1815 Princeton Lakes Dr. #709, Brandon, Florida 33511. The corporation may also maintain offices at other places within or without the United States.

ARTICLE III

Purpose

The specific and primary purposes for which this corporation is formed are to maintain and operate a religious corporation and to propagate and disseminate the religious principles embraced in the Bible.

The general objects and purposes for which this corporation is formed are to operate exclusively for charitable, religious or educational purposes, to include, but not limited to the following:

1. To establish, maintain and conduct a suitable organization to supervise the affairs of this corporation.
2. To license and/or ordain ministers of the Gospel and missionaries for the furtherance of the work of this corporation in the United States and all foreign countries in accordance with such regulations for ordination as shall be promulgated by the Board of Directors.
3. To establish, maintain, and conduct ministry and missionary endeavors for the furtherance of the Gospel in the United States and all foreign countries, according to the regulations promulgated by the Board of Directors.
