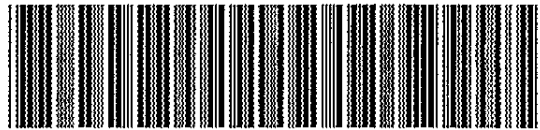

**ARTICLE I – NAME OF CORPORATION**


The name of the corporation is **SACHEL'S LAST RESORT, INC.**
