**ARTICLES OF INCORPORATION**

**OF**

**TEEN COURT OF DESOTO COUNTY, FLORIDA, INCORPORATED**

We, the undersigned, acting as incorporators of a corporation not for profit under Chapter 617 of the Florida Statutes, do adopt the following articles of incorporation for such corporation:

**Article One.**

**Name**

The name of the corporation is TEEN COURT OF DESOTO COUNTY, FLORIDA, INCORPORATED.

**Article Two.**

**Purposes**

The general purpose of the corporation is to provide juvenile law violators, between the ages of 10 and 17 years of age, with an alternative to the traditional juvenile justice system in the form of a Teen Court, and to transact any or all lawful business for which corporations may be incorporated under Chapters 607 and 617, Florida Statutes.

**Article Three.**

**Duration**

The duration of the corporation shall be perpetual.

**Article Four.**

**Principal Office and Address**

**Registered Office and Registered Agent

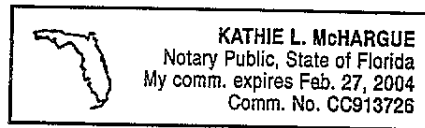

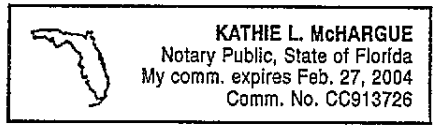
