ARTICLE I. The name of the Corporation is Lake Park Garden Club, Inc.

ARTICLE II. The principal place of business and mailing address for the corporation shall be: 754 W. Ilex Drive, Lake Park, FL 33403

ARTICLE III. The general nature and object of the non-profit corporation shall be: To organize themselves into a non-profit association for the purpose of engaging in activities which are charitable, educational and scientific within the meaning of *Section 501 © (3)* of the Internal Revenue Code of 1954. Specifically, the purposes of the association are as follows: (a.) To further the education of its members and the public in the fields of gardening, horticulture, botany, landscape design, conservation of natural resources, civic beautification, public sanitation and nature studies.

ARTICLE IV. The elected Officers of the corporation shall be a President, 1st Vice President, 2nd Vice President, 3rd Vice President, a Recording Secretary and a Treasurer. Each of such officers shall be elected annually at the first meeting in April. To be eligible for office, a candidate shall be a member in good standing and shall assume their duties at the close of the first meeting at which they were elected. The qualifications of members and the method of elections shall be regulated by the rules and regulations of the Bylaws of the Corporation.
