



TRIBAL RESOLUTION 5142016

The Council of ARCITO, meeting in full quorum on this 14th day of May, 2016, do here by resolve:

- *That the weight of historical evidence proves that the genesis of this Indian community originates in numerous diverse tribes including the Catawba, Cheraw, Lumbee, Nansemond, Saponi, and Creek, and*
- *That the sole inclusion of "Creek Indian" within the original naming of this Tribal Organization caused confusion among the citizenship of this Native community as elders continually professed that their ancestors originated "in the Carolinas", an area not historically the domain of the Creek Tribe, and*
- *That the sole inclusion of "Creek Indian" within the original naming of this Tribal Organization caused confusion among local, state, and federal legislators as ARCITO itself claimed a multi-Tribal origin and*
- *The inclusion of "Creek Indian" within the original naming of this Tribal Organization caused ARCITO to be viewed, in general, negatively as the "Creek Indian" designation has, in recent history, been claimed in the north Florida area by groups of phenotypically Caucasian associations of persons with a distant Creek Indian ancestor.*

For the above reasons the Council of ARCITO does hereby resolve that the portion of the Tribal Organization name that currently reads "Creek Indian" will be stricken from all official documents, correspondence, applications, etcetera and will be replaced by the term "Community of Indians."

I hereby attest that the above is a true and correct record of Tribal Resolution 5142016 introduced, seconded, voted, and passed by unanimous decision this 14th day of May, 2016.
