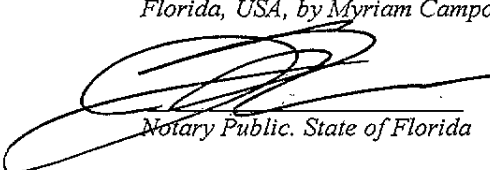
- I. The Florida for profit corporation **Harmony Development Center, Inc.** has filed articles of dissolution dated November 1, 2001.

ARTICLE I. Name
