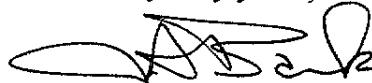

The undersigned subscribers to these Articles of Incorporation, a natural person competent to contract, hereby associate themselves together to form a corporation not for profit under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is: Mid Florida Developmental Disabilities Nurses Association Network, Inc.

ARTICLE II. PURPOSE

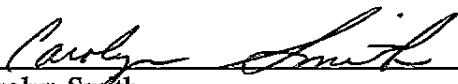
ARTICLE IX. AMENDMENT

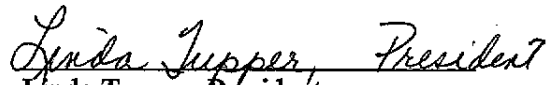
