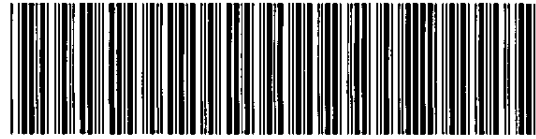

RESTATED ARTICLES OF INCORPORATION

WE, the undersigned, being members of the Board of Directors/Church Board of HIGHLAND PARK CHURCH OF THE NAZARENE, INC., having met and agreed for the purpose of RESTATING THE ARTICLES OF INCORPORATION of the existing non-profit corporation known as HIGHLAND PARK CHURCH OF THE NAZARENE, INC., and declaring that this restatement is adopted by the Board of Directors/Church Board and does not contain any amendments requiring member approval, in accordance with Florida Statutes, hereby RESTATE THE ARTICLES OF INCORPORATION as follows:

I.

The name of the organization shall be HIGHLAND PARK CHURCH OF THE NAZARENE, INC. The post office address of said corporation shall be 4777 Lakeland Highlands Road, Lakeland, Polk County, Florida.

II.

The purpose of the corporation is formed to make known to all peoples the transforming grace of God through the forgiveness of sins and heart cleansing in Jesus Christ. To conduct services and classes designed to reach people for Christ, make disciples, incorporate believers into fellowship and membership, and to equip (teach) for ministry all who respond in faith.

To accomplish these objectives, this corporation shall give power to distribute books, magazines, paper, audio, video, or other forms of media that will further carry out the objectives of this corporation. To permit the use of its property for Christian religious, educational, benevolent, and other lawful purposes as outlined in the denominational *Manual of the Church of Nazarene*.

III.

The acceptance, requirements, discipline, and removal of members shall be done in accordance with the denominational *Manual of the Church of the Nazarene*.

IV.

The term for which this corporation shall exist is to be perpetual.

V.

The affairs of the corporation shall be managed by an elected Board of Directors/Church Board, composed of the Pastor, who shall be Chairman ex Officio, the President of Nazarene Missions International, and the Trustees of the local church.

The Board of Directors/Church Board shall not be fewer than nine (9), nor more than fourteen (14). The Board of Directors/Church Board shall be composed of elected church members and may be elected from time to time by the annual Church Elections.

The Board of Directors/Church Board shall elect a Secretary and Treasurer.

The Board of Directors/Church Board shall approve an Executive Committee, appointed by the Lead Pastor, of no more than 4 members, with no more than one being a non-board member, if nominated. The Executive Committee will develop and oversee the details of the Church Budget. They may discuss confidential matters that are highly sensitive to advise or give counsel to the Lead Pastor and/or Board of Directors/Church Board as needed and/or as requested by the Lead Pastor.
