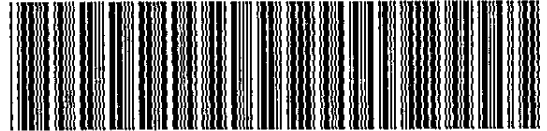

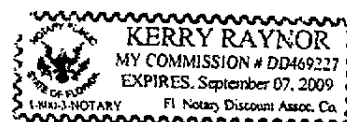

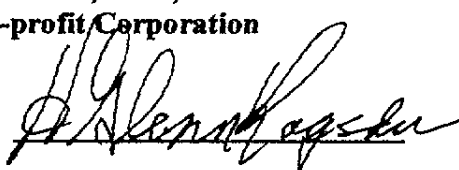
RESOLUTION CHANGING CORPORATION NAME
