ARTICLES OF INCORPORATION OF

Pursuant to Chapter 617, Florida Statutes, P.A.C.E. CENTER FOR GIRLS, INC., a Florida not-for-profit corporation (the "Corporation"), does hereby amend its Articles of Incorporation to change its name as follows:

1. Article One of the Articles of Incorporation of the Corporation is hereby repealed in its entirety and the following is substituted therefore:

FIRST: The name of this corporation is:

PACE CENTER FOR GIRLS, INC.

2. Except as amended hereby, the Articles of Incorporation of the Corporation shall remain in full force and effect.

3. The Board of Directors of the Corporation adopted and approved a resolution setting forth the proposed amendment in a written Action in lieu of a formal meeting of the Board of Directors on December 1, 1997. Pursuant to the existing Articles of Incorporation of the Corporation, the Members do not have a right to vote on this matter.
