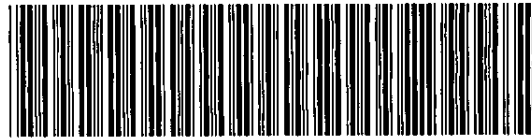

At a meeting of the Board of Directors of Cornerstone Hospice & Palliative Care, Inc. (the "Corporation"), held on January 29, 2014, in the presence of a quorum of the Board of Directors it was unanimously resolved upon motion duly made, seconded, and carried that the following amendment shall be made to the Articles of Incorporation in accordance with the provisions of Section 617.1006, Florida Statutes:

First: Article IV of this Corporation's Articles of Incorporation is hereby amended (the "Amendment") in its entirety so as to read, after Amendment, as follows:

**ARTICLE IV
GENERAL AND SPECIFIC PURPOSES**

The specific and primary purposes for which this corporation is formed are:

- A. For the establishment, operation, and maintenance of a hospice which responds to the special needs of the terminally ill patient and his/her family.
- B. To sustain Cornerstone Hospice & Palliative Care, Inc.'s present and future needs for real property, and improvements, personal property, staff development and training.
- C. To own, manage, coordinate and support the activities of its related not for profit corporations and limited liability companies engaged in activities related to the provision of palliative care services and/or hospice care and services.
- D. To operate exclusively in any other manner for such humanitarian, scientific, charitable and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code or under any corresponding provisions of any subsequent federal tax laws covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including private foundations and private operating foundations.

- E. Notwithstanding any other provisions of these Articles to the contrary, the Corporation shall not have or exercise any power which would cause it not to qualify as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code, nor shall the Corporation engage directly or indirectly in any activity which would cause the loss of such qualification.

Second: There are no members or members entitled to vote on the Amendment.

Third: The Amendment shall become effective upon filing with the Florida Secretary of State.

IN WITNESS WHEREOF, the undersigned has executed and signed these Articles of Amendment on behalf of the Corporation this 25th day of MARCH, 2014.
