We, the undersigned, herby associate ourselves together for the purpose of becoming incorporated under the laws of the state of Florida applicable to not for profit corporation under the following purpose: Article of Incorporation.

ARTICLE I CORPORATE NAME

The name of the corporation will be as follow: THE POTTERS HOUSE BAPTIST CHURCH of Miami Florida, Inc.

ARTICLE II

The Potters House Baptist Church, Inc. shall have it's location and seat of operation, as a church edifice at 555 North West 52 Street, in the city of Miami, County of Miami-Dade, and state of Florida, or any hereafter building or land purchased for said purpose i.e. church edifice to be used in a place of the present church edifice.

ARTICLE III
