ARTICLES OF INCORPORATION

OF

We, the undersigned, pursuant to Chapter 617, Florida Statutes, have associated ourselves together and do hereby associate ourselves together, for the purpose of becoming incorporated under the laws of the State of Florida as a corporation not for profit, and adopt the following Articles of Incorporation.

ARTICLE I- CORPORATE NAME

The name of this Corporation is: SWEETWATER COMMUNITY SERVICES, INC.

ARTICLE II - TERMS OF EXISTENCE

This Corporation shall have perpetual existence commencing upon the filing of these articles.

ARTICLE III- NATURE OF BUSINESS AND POWERS

The principal nature and purposes for which this corporation is organized are:

a) To assist adults in obtaining information and services for their health, welfare and well being; including living facilities, meals, transportation, work, immigration, special services, food stamps, insurance, medical care and other expenses, products and services provided by Children and Family services and other related and non-related governmental agencies.

The services would also be available for minors wherever necessary.

The members of this corporation shall be subscribers, and such other persons as may from time to time be elected to membership by the members of the corporation.
