

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: Wayne Ritchie Ministries, Inc.

ARTICLE II PRINCIPAL OFFICE
