# ARTICLES OF INCORPORATION OF BROTHERHOOD OF THE COAST, INC.

The undersigned, for the purpose of amending the Articles of Incorporation under the provisions of Chapter 617 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:
