**ARTICLES OF INCORPORATION OF  
P & B Youth Services , Inc.**

**A NOT FOR PROFIT CORPORATION**

I, the undersigned do hereby join together in the formation of a not for profit corporation pursuant to the laws of the State of Florida, following the terms and conditions, to wit:

**ARTICLE I**

**Name of Corporation**

The name of the corporation will be entitled:  
'P & B Youth Services , INC.',

**ARTICLE II**

**Principal Place of Business**

The corporation's principal place of business shall be located at P. O. Box 129, Jasper, Florida 32052. The Board of Directors may alter the principal place of business, to another Florida address.

**ARTICLE III**

**Purpose**

This corporation is a not-for-profit corporation formed for the purpose of providing training, treatment services, educational services and prevention services to youth ages 13 through 18 years of age, for the purpose of reducing juvenile crime and/or delinquency. The corporation will conduct activities and/or business that is educational, religious and/or charitable in nature as set forth in the Internal Revenue Service Code 501(c)(3).

**ARTICLE IV**

**Terms of Existence**

This corporation will operate under perpetual terms and will commence one business day after the receipt of accepted filing of this document.

**ARTICLE V**

**Directors**

The business affairs of the corporation will be conducted by a Board of Directors consisting of no less than (3) members at all times. The manner in which the Board of Directors will be elected/appointed shall be as set forth in the corporation's by-laws. 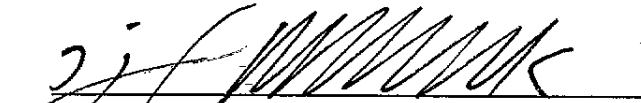

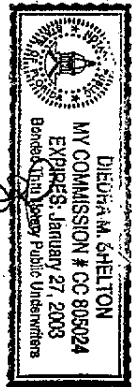

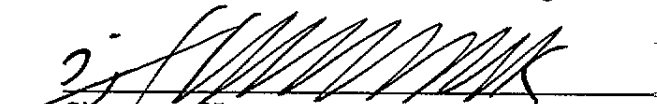

**Indemnification**

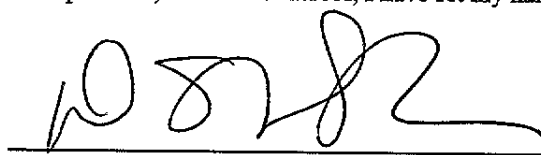
This corporation shall indemnify an officer or Board member, to the full extent permitted by law.
