Articles of Incorporation of Liberty Baptist Church, Inc.

The undersigned, being natural persons over eighteen years of age, pursuant to Chapter 617 of the Florida Statutes, Not-For-Profit Corporation Act, set forth the following Articles of Incorporation:

Article 1

The name of the corporation is Liberty Baptist Church, Inc.

Article 2

The corporation is a not-for profit corporation.

Article 3

The period of duration of the corporation is perpetual.

Article 4

The corporation is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the building of churches, parsonages, schools, chapels, radio stations, television stations, rescue mission, print shops, day-care centers, and camps; the evangelizing of the unsaved by the proclaiming of the Gospel of the Lord Jesus Christ; the educating of believers in a manner consistent with the requirements of Holy Scripture, both in Sunday and weekday schools of Christian education; and the maintaining of missionary activities in the United States and any foreign country.

Article 5

The street address of the principal office of the corporation is 204 N. Water Street, Starke, Florida 32091 and mailing address is P.O. Box 517 Starke, Florida 32091 and the name of the registered agent located at such address is Pastor Vaughn H. Foust, Sr.

Article 6

The corporation shall have members. The affairs of the corporation shall be managed by the board of directors. The number of the directors shall be fixed by the bylaws of the corporation, but may not be less than three (3).

Article 9

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article 4.

Article 10

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Article 11

The corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate against applicants, students, employees, and others on the basis of race, color, or nation or ethnic origin.

Article 12

Upon the dissolution of the corporation, the board of directors shall, after paying or making provision for payment of all the liabilities of the corporation, transfer all assets to a fund, foundation, or organization which is organized and operated exclusively for charitable, religious, or educational purposes and at that time qualifies as an organization exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

Article 13

Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986(or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
