Articles of Incorporation Of Salbour County School Boadiness Coo

Calhoun County School Readiness Coalition, Inc.

Article I - Name

The name of the corporation shall be Calhoun County School Readiness Coalition, Inc.

Article II - Registered Agent and Principal Office

The principal place of business and mailing address of this corporation shall be 450 Jenks Avenue, Panama City, Florida 32401. The initial registered agent of this corporation is Nicole Capps whose address is 4440 Putnam Street, Marianna, Florida 32446.

Article III - Purpose

The purpose for which the corporation is organized is to establish an integrated and quality seamless service delivery system for all publicly funded early education and care programs in Calhoun County.

Article IV - Members

The membership shall be composed of at least eighteen (18) but not more than twenty-five (25) members. The composition of the board must conform to the provisions of the Section 411.01(5)(a), Florida Statutes and appointed and elected as stated and provided for in the bylaws.

Article V - Officers

The officers of this corporation shall be elected or appointed by the coalition members to serve for one term. There shall be a chairman, a vice chairman, and three additional members, comprising the executive committee, each of whom shall be a member of the coalition. The members may from time to time elect or appoint additional officers who shall also be members of the coalition.

Article VI – Non-Stock Basis

The corporation is organized under a non-stock basis.

Article VII - Duration

The corporation shall exist perpetually, unless dissolved according to law.

Article VIII - Dissolution

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes with in the meaning of section 501(c)(3) of the United States Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by an organization or organizations selected by an affirmative vote of a majority of the Directors, provided, however, that such organization or organizations are recognized as exempt from federal income taxation under Section 170(c)(2) of the Internal Revenue Code of 1986, as amended, or corresponding sections of any prior or future law.

Article IX - Corporate Powers

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes.

Article X - Incorporators

Article XI – Amendments
